

STONKLEEN SG2

PRODUCT DESCRIPTION

Stonkleen SG2 is a oxidizing cleaner containing 0.02% Sodium Hypochlorite plus cleaning agents that clean and oxidize organic soils. Chlorine bleach is still the most relied upon chemical to protect public health. It is suitable for use on most surfaces cleaned with detergent and water.

TYPICAL USES

Stonkleen SG2 is used in the public sector designed for food service areas, restroom hygiene programs and institutional sanitation programs.

DIRECTIONS FOR USE

- Apply Stonkleen SG2 oxidizing cleaner to the surface of the floor using a spray applicator or a mop.
- Allow the cleaner to soak for 3 to 5 minutes, then damp wipe and rinse.
- For stubborn soils, agitate.
- Repeat if necessary.

Note: If daily disinfecting is desired, dilute 0.5 ounce of Stonkleen SG2 with one gallon of water.

PACKAGING

Stonkleen SG2 is available in units.

Each unit consists of:

(4) 1 gallon containers (FG#8009A41)

or

(1) 5 gallon container (FG# 8009A5)

STORAGE CONDITIONS

Store Stonkleen SG2 between 60 to 85°F/16 to 30°C. Keep from freezing.

APPLICATION

Stonkleen SG2 can be used with a mop, scrub brush or automatic floor machine.

RECOMMENDATIONS

- Adjust your dilution ratio to optimize cleaning performance or to effect greater economy.
- Use all proper PPE.
