

STONKLEEN TD9

PRODUCT DESCRIPTION

Stonkleen TD9 is a heavy-duty buildup remover that effectively removes tire marks found on floors in manufacturing and warehouse facilities. It can also be used as a heavy-duty degreaser of petroleum oils and metal oxides.

TYPICAL USES

Stonkleen TD9 is used in manufacturing facilities to remove tire marks, grease and oils from vinyls and other hard surfaces.

DIRECTIONS FOR USE

For normal accumulation.

- Dilute 12 ounces of Stonkleen TD9 to each gallon of water.
- Apply to floor with mop or autoscrubber.
- Rinse with water.
- Repeat as needed.

For cleaning heavy buildup accumulations.

- Dilute 32 ounces of Stonkleen TD9 to each gallon of water.
- Apply to floor surface with mop or autoscrubber.
- For tire marks a buffing machine equipped with a white scrubbing pad is recommended.
- Rinse with water.
- Repeat as needed.

For heavy solid spot removal.

- Use concentrated Stonkleen TD9.
- Apply to floor with a small amount of water and agitate.
- Allow to penetrate for 2 to 3 minutes.
- Extract and rinse thoroughly.

PACKAGING

Stonkleen TD9 is a concentrated liquid and is available in:

- (4) 1 gallon containers (FG#8013A41)
- or
- (1) 5 gallon container (FG# 8013A5)

STORAGE CONDITIONS

Store Stonkleen TD9 between 60 to 85°F/16 to 30°C. Keep from freezing.

APPLICATION

Stonkleen TD9 can be used with a mop, scrub brush or automatic floor machine.

RECOMMENDATIONS

- The dilution ratios stated are approximations. Adjust your dilution ratio to optimize cleaning performance or to effect greater economy.
- Use all proper PPE.
